

# Key investor information

## Objectives and investment policy

#### Objectives

The Fund seeks to provide income with the potential for capital growth in the medium term (3 to 5 years).

### Investment policy

The Fund invests at least 80% of its net asset value in equities of companies listed in the UK, and securities which represent rights in such shares. The Fund may also invest up to 20% of its net asset value in other asset classes including equity securities of companies listed in jurisdictions other than the United Kingdom, equity securities of companies that are not yet listed on a stock exchange, fixed interest and/or debt securities, indices, money market instruments and deposits. The Fund will invest in line with the requirements of the Investment Manager's Climate Change Mitigation Policy (as further described in the investment strategy in the prospectus).

The Investment Manager aims to construct a portfolio for the Fund that seeks to promote climate change mitigation through an investment process which assesses a company's alignment to, or commitment to align to net zero greenhouse gas emissions by 2050.

The Investment Manager also assesses the corporate governance practices of companies in which the Fund may invest. The asset classes to which this investment process applies are set out in the Investment Manager's Climate Change Mitigation Policy on the Investment Manager's website at <a href="https://www.taml.co.uk">https://www.taml.co.uk</a>. It does not apply to other assets within the Fund.

The Fund has no specific economic or industry focus. The Fund will have significant

exposure to assets denominated in pound sterling.

Derivatives (a contract the value of which depends on the value of one or more underlying assets) may be used to manage the risk profile of the Fund, reduce cost or generate additional capital or income.

#### Benchmark:

The Fund is actively managed. The Fund has the discretion to invest in the investments as described above with no need to adhere to a particular benchmark. The FTSE All-Share Index (Total Return) is used for performance comparison only against GBP equity returns.

### Essential features of the Fund:

The reference currency of the Fund is expressed in GBP. The currency of the Share Class is expressed in SGD.


You can buy and sell shares in the Fund each business day. The attention of the investor is drawn to the fact that in exceptional circumstances, the possibility to request the purchase or redemption of shares may be limited or suspended.

These shares are capitalisation shares. Income and capital gains are reinvested.

#### Recommendation

This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

### What does this synthetic indicator mean?

The shares of Class O SGD Accumulation are classified in category 5 because the value of the share may be subject to high variations and consequently the risk of loss and the opportunity of gain may be high.

# Which materially relevant risks are not adequately captured by the synthetic indicator?

Liquidity risk: Smaller companies' securities are often traded less frequently than those of larger companies which means they may be more difficult to buy and sell. Their prices may also be subject to short term swings.

Sustainability risk: The investments of the Fund may be subject to sustainability risks, meaning an environmental, social or governance ("ESG") event or condition that, if it

occurs, could cause an actual or a potential material negative impact on the value of an investment.

Position / Market risk: The investments of the Fund are subject to normal market fluctuations and the risks inherent in investment in securities markets and there can be no assurance that the value of the relevant securities will go up in value or that the investment objective will be achieved.

Financial techniques impact: The Fund may use derivatives to generate additional capital or income. A movement in the value of a derivative's underlying asset may have a much larger negative impact on the value of the Fund than if the Fund were to hold the underlying investment itself.

Counterparty risk: There is a risk that other parties may fail to meet their obligations. This may lead to delays in receiving amounts due to the Fund, and the Fund may receive less or nothing.

Currency risk: As the Fund invests in securities which are not in the base currency, movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.

Currency designation risk: The Share Class is designated in a currency other than the base currency of the Fund. Changes in the exchange rate between the base currency and such designated currency may lead to a depreciation of the value of such shares as expressed in the designated currency.


The conversion of part or all of the shares into shares of another Fund or another Share Class is free of charge.
