What is this product?

Type Term The product (hereinafter also referred to as the "Fund") is a sub-fund of the ICAV. The ICAV has been established as a UCITS fund in Ireland.

The Fund was created for an indefinite term. Investors may redeem shares in the Fund on any Dealing Day (e.g. a weekday which banks are open for business in both Dublin and Frankfurt am Main).


Objectives

The Fund is actively managed with reference to MSCI North America High Dividend 33.33%, MSCI Europe High Dividend 33.33%, MSCI Pacific High Dividend 33.34% as a performance measure. The investment objective of the Fund is to increase the value of its investments over the long term. The Fund seeks to achieve its investment objective of achieving long-term capital appreciation by providing investors with access to a diversified global equity portfolio. The Fund will invest predominantly in global equities. The selection of international equities is limited to issuers from globally developed industrial countries. This investment selection process is applied to three regions, to which each stock is allocated according to its corporate headquarters (North America, Europe including UK and Pan Asia including Japan, Australia, Hong Kong and Singapore) and is carried out by applying the proprietary quantitative selection process of the Investment Manager. Up to 10% of the Net Asset Value of the Fund may be invested in Collective Investment Schemes (including EU domiciled exchange-traded funds and those managed by the Investment Manager). The investment policy of such Collective Investment Schemes will be consistent with the investment policy of the Fund. The fund may perform derivative trades in order to hedge positions or to increase its returns. Returns from the Fund will be distributed (where applicable, of this share class). The Fund's assets are held with its depository, which is J.P. Morgan SE - Dublin Branch. Intended retail investor

The Fund is designed for investors who already have a certain level of experience with financial markets. The investor must be prepared and able to accept fluctuations in the value of the Shares and the potential of a significant loss of capital. The assessment of the Manager should not be considered investment advice; instead, it is intended to provide the investor with an initial point of reference for determining whether the Fund is appropriate for their investing experience, risk tolerance and investment horizon.

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. We have classified this product as 4 out of 7, which is a medium risk class. What happens if the Manager is unable to pay out?

Cost over time

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
