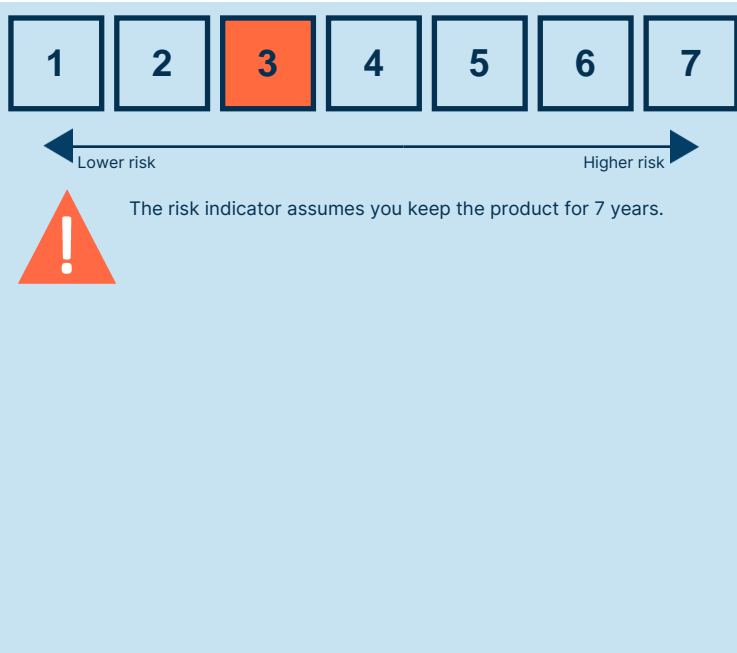

What is this product?

Type	The product is an investment fund in the form of a fonds commun de placement (FCP) pursuant to Part I of the Luxembourg Law of 17 December 2010 on undertakings for collective investment ("Law of 2010") and pursuant to Directive 2009/65/EC of the European Parliament and of the Council of 13 July 2009 on the coordination of laws, regulations and administrative provisions relating to undertakings for collective investment in transferable securities.
Term	The term of the Fund is unlimited, so there is no maturity date. The Fund may be dissolved and liquidated under the specific circumstances set out in the Management Regulations.
Objectives	The Fund is actively managed. As an investment objective, the Fund strives for a sustainable, attractive return, while accepting short to medium-term fluctuations in value (total return focus over several years). The aim is an appropriate participation in rising markets and a certain protection of capital in declining markets. To achieve this, the fund pursues an active investment approach and deliberately does not follow any benchmark index. The Fund Manager can invest flexibly and with almost no restrictions in investments across all asset classes and regions, which from his point of view appear attractive in the capital market environment concerned. The Fund generally seeks to diversify risk by investing in different asset classes, sectors, currencies and countries around the world. The Fund invests directly in individual stocks, funds, ETFs and derivatives. For comparable investment alternatives, ESG-compliant investments are preferred. There are neither fixed quotas nor fixed bandwidths for the individual asset classes. In the long term, the aim is to achieve an equity ratio of more than 50%. When controlling the overall alignment of the Fund with regard to the main risk factors, the Fund Manager uses the market assessment of his multi-asset team, which is based on a stringent and transparent investment process. In the process of selecting suitable investments, the fund considers environmental and/or social characteristics and is classified as a financial product within the meaning of Article 8 of Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector. The Fund may perform derivative trades in order to hedge positions or to increase its returns. No reference is made to a benchmark in managing the Fund. What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you. This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the Fund and a suitable benchmark over the last 12 years. Markets could develop very differently in the future.

What happens if the Manufacturer is unable to pay out?

The failure of the Manufacturer will have no direct impact on your payment, since statutory regulations required that, if the Manufacturer becomes insolvent, the fund does not become part of the insolvency assets, but rather remains separate.

What are the costs?

Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. - In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take my money out early?

Recommended holding period: 7 Years

This product does not have a mandatory holding period. The recommended holding period is based either on historical data or the Manufacturer's estimate regarding the average fluctuation in the unit value, which is to be expected for this product. If you, as an investor, have a shorter investment horizon, the risk is on average higher than at the time of redemption, the unit value of the product will be lower than when you invested. There are no redemption costs or fees. However, you may return the product in accordance with the procedures indicated in the Sales Prospectus. In order to protect the interests of unitholders, the Manufacturer may decide to temporarily and partially restrict the right of unitholders to redeem their units so that unitholders may redeem only a certain portion of their units. In order to protect the interests of the unitholders, the Manufacturer may decide to temporarily extend the usual notice period that unitholders must observe when making redemption requests for their units/shares to the Manufacturer.
